Classification of Halal Product/Service Categories

The Halal CB shall use Table A-1:

- to define the scope that it undertakes,
- to identify if any technical qualification of its auditors is necessary for that particular category or sector, and
- to select a suitably qualified audit team.

The examples given in Table A-1 are not exhaustive but are only an indication of relevant topics. The scope of one specific client organization may cover more than one category;

Preparation of Quotation and Contract

From the results of the Application Review, the quotation is prepared (FMP01/03) by Manager Certification in consultation with MR. The Quotation is dispatched/mailed as required to the client with the Contract (form FMP01/04), which is to be returned with the signed contract through suitable means. Signed quotation and contract shall be saved in soft data by MR.

Renew Contract

If third year review identify the need for the amended quotation the information for the quotation is prepared through a contract review based upon the customer's history found in the CDB/customer file.

5 Application Review

Before proceeding with the audit, the QESI shall conduct a review of the application and supplementary information for certification to ensure that:

- a. the information about the applicant and its product(s) / service(s) and / or management system is sufficient for the conduct of the audit
- B. the requirements for Halal certification are clearly defined and documented, and have been provided to the applicant;
- C. any known difference in understanding between the Halal CB and the applicant is resolved;
- d. the Halal CB has the competence and ability to perform the Halal certification activity;
- e. the scope of certification sought, the location(s) of the applicant organization's operations, time required to complete audits and any other points influencing the certification activity are taken into account (language, safety conditions, threats to impartiality, etc.);
- F. records of the justification for the decision to undertake the audit are maintained

Following the review of the application, the QESI shall either accept or decline an application for certification. When the QESI declines an application for certification as a result of the review of application, the reasons for declining an application shall be documented and made clear to the client.
